1. Discussion: Sonoma County's General Plan focusing on the Environmental Justice and Safety Elements Update -Claudette Diaz, and Katrina Braehmer, Permit Sonoma

- There will be a larger outreach concerning the General Plan (GP) in January, 2025.
- Two elements of the GP have to move forward because of the state law required deadline.
  - Public Safety Element; proposing changing name to Safety Element.
    - Developing the new Environmental Justice Element.

Safety and Environmental Plan

- It began with a short definition of a general plan.
- Described the purpose of the existing safety Element and the new requirements
- Described and defined the New Environmental Justice Element.
  - This is in the developmental process. They are now looking for feedback, questions and ideas from the community. Not making recommendations at this point.
- For the Safety Element they found the highest priorities for the Mark West community are: emergency preparedness and response, wildfire, and resilient landscapes.

### Safety Element

Emergency Preparedness and Response Issues

- All are issues important:
  - Broken accessibility barriers, evacuation access, transportation issues
  - Work with HOAs and neighborhoods, neighbors helping neighbors knowing of (and where) places to go
  - Have centers in communities.
- Evacuation facilitation
  - Ability to identify who/where some people need help
  - Neighborhood watch programs, evacuation drills, evacuation maps
  - Ability to drive on wrong sides of roads, escape plans
  - Plans for schools to move students out to their communities, same for mobility challenged and elderly community (day and night)
  - Maybe voluntary register to request assistance.
  - Suggest HOAs modernize rules for fire safety.

- Consider the impact from the Koi Casino proposal. May have to adjust to deal with issues it could cause.
- Who would maintain/update neighborhood info over years/decades?

#### Wildfire Issues

- Use the education system to communicate to people. Schedule, on a regular bases, in each community, where the hub is and use phone trees.
- Post fire relocation strategies Consider where to post available temporary housing.
- Hold community events, emergency preparedness fairs, safety expos, farmers markets.
- Again...communication, registers for locating people and to list places for the public to go at the community level
- Find the hub in each community
- Engage social services, schools, etc, phone trees

### Environmental Justice Element (Healthy Environments)

#### Pollution Exposure

Particulates from fuels will be becoming a big consideration. Also fuel and pollution from airplanes.

#### Clean Water and Stewardship

- Minimize various runoffs.
- State or grants to pay for supplement well testing and/or updating
- Better communication between State and County about trickle-down opportunities to local communities
- Help homeowners upgrade to sewer systems.
- Sonoma County Energy Independence Program (SCEIP) type programs for water wells/septics ec.
- Traffic on Mark West and Old Redwood Hwy. Find funding to reduce roads to one lane in each direction with trees in the center.
- Smoke Pollution, air traffic with particulates coming down out of the air
- Clean-air centers similar to heating or cooling centers
- Air purifier accessibility

### Systemically Marginalized Communities

- Need translators; have written communications in Spanish.
- Be aware people are complex and made up of more than one identifier of a community.

### Varying Age Demographics

- More senior centers
- Identify Molsberry's as a center for communications in the Mark West area.
- Get better communication for those who don't use electronics.
- Better access to helping people get medications
- Bull horns and air raid sirens

Put grant funding sources in the General Plan.
