#### 1. Welcome & Introductions

- Sage Limpp, Sonoma DEM, welcomed attendees, and shared the purpose of the meeting.
- Jeff Duvall, Sonoma DEM, provided opening remarks and thanked attendees for their participation.
- Bart Spencer introduced those from Tetra Tech assisting with the plan update highlighting the point of contact, Lead Planner, Sasha Jones, before presenting slides to the group.

#### 2. HMP Update Overview

- Provided overview of hazard mitigation, the hazard mitigation plan purpose, and the reasons for updating the 2021 plan.
- Introduced the five groups involved in the HMP Update: Hazard Mitigation Working Group; Planning Partners; Stakeholders; Public; and Planning Team
- Outlined planning process to take place over the next year and identified the current plan progress.
- Provided overview of public outreach requirements and strategies including the Sonoma DEM mitigation <u>website</u>, public mitigation <u>survey</u>, social media posts, and upcoming public meetings, StoryMap, and public comment period.

#### 3. Roles and Responsibilities

- Hazard Mitigation Working Group responsibilities include participating in the process, attending meetings, and socializing the plan to the community.
- Attendance is tracked and each participating organization must identify an alternate to attend in their place if the primary member is unavailable.

#### 4. Key Decisions

- Selection of the Chair and Vice Chair
  - Sage Limpp, Sonoma County DEM, was unanimously voted in as the Chair.
  - Kim Jordan, Town of Windsor, was unanimously voted in as the Vice Chair.
- 2026 Hazard of Concern
  - Discussion considered the inclusion of insects and pandemics in the hazards of concern, HMWG determined that many of the non-natural hazards are covered by existing Sonoma County <u>emergency management plans</u>.

#### 6. Questions

#### How will the new Fire Hazard Maps from Cal Fire be incorporated into the plan?

Answer: The County GIS personnel identifies the best data sources for each hazard. Generally, the order of preference is county, state, federal. The county will determine whether they will use the CAL FIRE maps or a local data source, if it exists.

#### will this plan use the County CWPP hazard/risk mapping?

Answer: The plan will include an analysis of all local and county plans related to hazard mitigation, including CWPPs. As for whether we use the CWPP data for our risk analysis, that decision will be made by the County GIS personnel. If there are any plans that contain data that the County GIS team does not know about, please flag for Sage's attention.

Answer: The County GIS personnel will determine which data sources to use to evaluate the hazards.

#### How do we know if our jurisdiction in participating in CRS?

Answer: Visit the <u>FEMA Community Rating System website</u> and scroll down to CRS Participating Communities. You can download either a PDF or Excel spreadsheet that lists all participating communities, their CRS Class, and their flood insurance premium discount. Currently in Sonoma County, the City of Petaluma is a Class 6 and the County is a Class 10.

#### Will we ensure that all public outreach materials are in both English & Spanish?

Answer: Yes, all public outreach by the County will be conducted in Spanish and English. Participating jurisdictions are encouraged to offer the same.

#### How long will the survey be open?

Answer: There is not currently a closing date for the public outreach surveys. Generally, the surveys remain open for several months to allow time for as many responses as possible.
