1. Welcome & Introductions

- Each person was asked to share their name, title and department in the chat.
- Sage Limpp, Sonoma DEM, welcomed attendees, shared the purpose of the meeting and introduced Bart Spencer from Tetra Tech.
- Tom Jordan and Neil Bregman introduced themselves as representative from the Cities of Petaluma and Santa Rosa.
- Bart Spencer introduced those from Tetra Tech assisting with the plan update highlighting the point of contact, Lead Planner, Sasha Jones, before presenting slides to the group.

2. Hazard Mitigation Overview

- Mitigation is a sustained action taken to reduce or eliminate long-term risk to life and property from a hazard event.
- A Hazard Mitigation Plan (HMP) provides an overview of the impacts of natural hazards on communities and is a roadmap to reducing the impact of these hazards.
- For the 2026 update, the County will be following the revised April 2023 FEMA guidance for local plans.
- Two main reasons to update plan:
 - Have an active and valid plan to become eligible for funding.

 It's a proactive strategy to anticipate potential challenges the county might encounter and to determine measures to minimize or prevent the impact of these hazards.

3. Key Agencies, Partners, and Stakeholders

- To complete the HMP update, we will work with individuals, agencies, neighboring jurisdictions, businesses, and other partners.
- The project is organized by the following -
 - Core Planning Team made up of Sonoma County, Cities of Petaluma and Santa Rosa, and Tetra Tech. This is a small group that will meet frequently to ensure the project stays on schedule and that we meet all State and FEMA requirements.
 - Planning Partnership responsible for providing guidance and leadership throughout the planning process. They will actively contribute, review, and provide feedback on plan sections, update the plans' goals and objectives, finalize the list of hazards of concern, and identify mitigation actions.
 - Hazard Mitigation Working Group (HMWG) represents the participating jurisdictions. They will attend meetings, provide information, identify mitigation actions, and adopt the HMP.
 - Stakeholders must be engaged throughout the planning process. At a minimum, this group should include neighboring counties, local and regional agencies involved in hazard mitigation activities, and agencies that have the authority to regulate development, as well as businesses, academia, and other private and nonprofit organizations. We will put together a draft list of stakeholders and ask for your input.
 - Cal OES and FEMA provide the County guidance throughout the HMP update and will review/approve the plan.

4. Planning Process Overview

The Planning Team will follow an eight-phase approach to update the HMP:

- 1. Planning Process ongoing throughout the update
- 2. Risk Assessment identifies the risks of each hazard included in the plan.
- 3. Public Involvement Strategy ongoing throughout the plan update; we will use the County's website and StoryMap to help with outreach.
 - a. New FEMA guidance emphasizes outreach to socially vulnerable communities and to include these populations in the Risk Assessment
 - b. Planning Partnership members suggested the following categories for inclusion in the social vulnerability analysis.

- 4. Mitigation Strategy review/finalize goals/objectives for 2026 HMP; review existing capabilities; review 2021 mitigation strategies and provide status; identify new strategies for the 2026 update.
- 5. Plan Maintenance determine the maintenance schedule of the 2026 HMP.
- 6. Plan Update and Deliverables update all sections of the HMP; provide to Cal OES for review and approval.
- 7. Plan Adoption the County and each participating municipality will adopt the plan after the HMP is approved by FEMA.
- 8. Project Management and Coordination ongoing throughout the update

 - o Risk assessment results Spring 2025
 - Public Involvement Ongoing
- Mitigation Strategy

- Plan Maintenance Summer 2025
- Public Draft Fall 2025
- Draft to State for Review Fall 2025
- Plan Adoption Early 2026

Answer: Jurisdictions will meet periodically, planning partners may meet several times, even 1:1 meetings. HMWG will mee about four times, and the planning team will meet every other week. There will be public meetings from time to time, which will be scheduled after the first of the year.
