3. General updates – Kris Hoyer

- a. Division updates
 - i. 217 under supervision, 55 in the Hall

- ii. SYTF-1 in the community
- iii. We now have a specialized PO for SYTF youth
- iv. Lots of interest in Juvenile Hall positions both internally and Marin/Mendocino/Lake
- b. Juvenile sex offender treatment – Dan Flamson
 - i. SFFI is our provider, it has been impacted by capacity issues. Working to remedy.
- c. Evaluation Planning – Rob Halverson
 - i. Looking for an evaluator for our SYTF Juvenile Hall programming
 - ii. Goal: Will let us know what services youths received, how much, and how well it went.

4. Discussion: Assembly Bill (AB 505) updates-Brad Michnevich

- a. The Probation will continue to:
 - i. Submit its Annual Plan to the OYCR by May 1
- b. Changes as a result include:
 - i. Previously, the JJRS only met once every three years after submission of the original Plan in 2022; now, shall meet two times per year
 - ii. Ability of the ombudsperson, following a complaint from a youth, to inspect Juvenile Hall, its records, contractors to JH and their records, and interview youth and others related to the complaint.
 - iii. The Ombudsperson a part of OYCR, but not in their area so no cross-contamination
 - iv. It is triggered by a complaint
 - v. OYCR provided resources in CAPIA showing Ombudsperson data received from visits, ex: # of complaints, type of complaints (food, facilities, etc.)

5. Discussion: Potential Office of Youth and Community Restoration Grant

- a. There are funds available for the Least Restrictive Placement (LRP) of youths
 - i. Up to \$250,000 per youth
 - ii. Very broad parameters for what the programming can be, ex: housing, job training, fire academy, etc.
 - iii. This works for us since youth plans are so individualized, not standardized.
 - iv. Is Camp a possibility?
 - 1. Given the low number of youth who would go out there, we can't justify all of the funding for Camp at this time
- b. We sent a letter based on the Request from OYCR
- c. It was tentatively approved for 1.4m, in the coming year

- a. How have the FFPSA (prevention-oriented) funding play into this?
 - i. We have been successful with FFT, and our collaboration with HSD-FYC.
